Code Red Fire Fighting Kits Recall





Alaska Department of Environmental Conservation established the Firefighting Substance Disposal Reimbursement (FSDR) program

CODE RED portable firefighting kits were distributed to communities around Alaska from 2003 to 2009. The Code Red fire safety kits contained firefighting substances known as Aqueous Film-Forming Foam (AFFF), which consisted of per-and polyfluoroalkyl substances (PFAS). Not every community received a CODE RED kit, and most were issued to the city office, so please check with them. The DEC's FSDR program top priority is to ensure that the CODE RED AFFF is disposed of properly.

Protecting Traditional Drinking Water Sources

We are working with Tribes across the Yukon River Watershed to record and sample traditional drinking water sources for PFAS contamination. These water sources are sacred, and we want to ensure they remain safe for future generations. If your Village has a traditional drinking water location, we encourage you to consider allowing us to visit, pay respects, and conduct water sampling. Your participation will help protect these vital sources for years to come.

Support for Sewer Lagoon Maintenance & Upgrades

With breakup season approaching, we know that many Villages will be dealing with wastewater challenges. funding We have available provide technical assistance improving and maintaining sewer including lagoons, support fencing, signage, and landscaping upgrades to improve safety and functionality. If your community needs help preparing for breakup or addressing lagoon issues, please contact us.

QuickBooks Training for Village Administrators

Managing finances effectively is key to running a successful utility system. This summer, we will be offering a QuickBooks training course designed for village administrators and utility managers. Upcoming Solid Waste Management & Waste Reduction Workshops

This summer, we will be hosting several Solid Waste Management and Waste Reduction workshops to support Villages in improving waste management practices. Some trainings will be held virtually, while others will take place in person. We have funding available to travel to Villages and provide hands-on training tailored to community needs. We offer assistance in creating, updating, or revising SWMPs to meet the specific needs of each village. We can provide technical guidance, funding resources, and best practices to help develop a sustainable and effective waste management strategy.






Indigenous Observation Network (ION) Updates


The ION has been funded by the National Science Foundation over the past five years and as the funding is coming to an end, I have been mostly working on data control and analysis. These data analysis will provide us a deeper understanding about long-term temporal and spatial trends across the watershed. Some examples of data analysis of chemical trends and average water temperature is illustrated in these graphs.





Detailed community data analysis and interpretation will be shared with you via the 2025 Water Quality Report by end of April. I am also have been working on proposal development for the program funding continuation. The framework of the proposal links the themes of water quality, hydrology, landscape changes and traditional knowledge to elevate our water stewards.






As I am in the proposal development phase, I deeply would appreciate any of your guidance or ideas or framework recommendations changes. The ION is driven by you and I want to be sure the proposal addresses your environmental monitoring concerns and needs.

Mining Watchdog Program

We are excited the Mining Watchdog Program received funding from the Native American in Philanthropy network. Funding provides the opportunity to conduct intensive water quality monitoring this summer. The water quality data collected will serve to monitoring potential mining impacts or to create baseline data to understand natural river or stream conditions. The data results will become available on our interactive map on mining activity within the Yukon River Watershed.

YRITWC Climate Change Adaptation & Action Plan for the Yukon River Watershed

In 2023 we hosted series of water resilience workshops to create space for discussions about local and regional vulnerabilities such as climate driven environmental or pollution impacts to water resources. The workshops were attended by 32 Tribal leaders, IGAP professionals, youth and Elders, who shared their perspectives on water resilience strategies to support mitigation, preservation or conservation efforts.
