An appreciative thank you to James Akerelrea for serving as the outgoing Coastal representative Newly elected alternates are Dacho Alexander for the Yukon Flats, Lawrence Ketzler for the Tanana River, Darrel Vent Sr. for the Koyukuk River and Eucebias for the coastal communities regions. Thanks go out to Josie Dayton, Victor Lord, and Wassily Alexie for serving as outgoing alternates.

Since the Summit, I have had the opportunity to meet with Chuck Sams, National Director for the National Park Service with our tribal member village chiefs from Alatna, Bettles, Evansville, and Tanana where we got to address opposition to the Ambler Road. In 2019 our membership passed a resolution to oppose Ambler Road. The DOI Bureau of Land Management will be conducting public hearings and taking comments until December 16, 2023. We encourage you to make comments about how this proposed road will affect your ability to hunt, fish and subsist. A special thanks goes to Executive Committee member Kathleenn Peters-Zuray who has represented YRITWC, locally and nationally expressing opposition to the Ambler Road to carry out the provision of this YRITWC resolution.

Science Projects Updates

Halloween passed and winter is on the way, which means Indigenous Observation Network (ION) monitoring field season is completed for 2023. It has been another successful open water season with over 170 water samples and physical water quality measurements collected cross the Yukon River basin. Additionally, the ION Team visited 12 active layer sites to collect active layer depth, soil moisture and temperature data in order to achieve a deeper understanding about landscape changes, such as permafrost thawing and its influences to water quality. The next couple of months, I will be working on community reports to share our collected ION data that will illustrate long-term trend records in your region.



For the Arctic Rivers Project, a collaboration between the University of Colorado Boulder, USGS, National Center of Atmospheric Research, Institute for Tribal Environmental Professionals and YRITWC, we were able to install 14 sensors with the help of your Tribal and First Nations environmental programs. These sensors have measured continuous water temperature and conductance over the past three summers. The data generated by these sensors will be combined with the project river modeling activities as well as shared via your community reports this spring.







We worked on expanding our Yukon Stewards Mining
Watchdog Program to enhance the capacity of Alaska Native
Tribes to respond to historical and active mining impacts to
water resources. Thanks to the support of the Lannan Foundation
we were able to collect water samples around the Tolovana,
Circle and Chicken mining district. Additionally, we established
new sample sites at the Koyukuk River headwaters and at the
Tanana River above Tok.

The science team also assisted the Hooper Bay Traditional Council with their landfill and sewage lagoon site assessment, supported the Alakanuk Traditional Council with their landfill sampling effort, and assisted the EPA RESE team with the Northway and Nulato landfill assessments this fall.

Another river erosion season has been completed with our project partners, the University of Alaska Anchorage, the California Institute of Technology, the Los Alamos National Laboratory, and the University of Southern California. This project aims to develop capacity for planning and adapting to riverbank erosion at Huslia, Alakanuk, and Beaver Village.





I also would like to express a huge "Thank You!" to the Alaska Conservation Foundation and the Institute for Tribal Environmental Professionals for their support that provided us with the opportunity to host two interns this season. Amy Patterson and Annalee Bishop has been a huge help to support tall the science efforts.

IGAP

In October, Theo and I attended the Solid Waste Bootcamp held by the ADEC to strengthen our ability assist with ISWMPs, Backhaul, and other solid waste issues. Lastly, reporting. I'm sure you are all in the same boat, with the end of the fiscal year and the start of the new year, it's a busy time. Especially for those who had to close out a multi-year grant – Congratulations to you!

The FY25 NOFA was released and we're looking forward to submitting our proposal for the next 5 years. The preliminary draft is due to your project officer by January 19th! Updates from TRP: Networking, Outreach, and Funding Opportunities

TRP has been eagerly pursuing its goals in recent months. In July, the biennial Watershed Summit was held, which Jordan and Ben attended. Later in August, they also part the **National** took in Brownfields Conference, expanding their network and gaining insights into funding opportunities. Jordan also visited Rampart as part of the program. Additionally, outreach applied for the TRP **Targeted** Assessment (TBA) Brownfield program in Chevak after being approached for assistance with a brownfield site. Regarding Hughes' TBA. the Phase II has been postponed to next summer, while a Phase I has been completed in St. Mary's. Currently, TRP is working on securing funding for the next steps.

Recent Community Meetings and Assessments: Progress Update

We're excited to share that we successful hosted community meetings in Grayling, Russian Mission, Huslia, and Alakanuk. In July, Phase I assessments were Huslia carried out in and Alakanuk. while Russian Mission's Hazardous Building Material Inspection (HBMI) was in completed August. Additionally, Grayling had its Phase II conducted in October. These are big strides towards cleanup! We're currently waiting for the final reports from the contractors. Once we receive them, we'll create action plans to determine the next steps for each site.

Thanks to support from the Lannan Foundation we have been ramping up our involvement in environmental regulatory issues around mining. We went to Fairbanks and Theresa Clark and Katherine Peters-Zuray made virtual comments about failings of the DSEIS for the Ambler Road to address climate change, the effects to water quality to the surrounding area, as well as the impacts to our traditional and subsistence ways of life.



We attended the AKMIN (Alaska Mining Impacts Network) annual meeting in October and gained valuable knowledge and partnerships. We also submitted written comments and letters about the state assumption of the CWA 404 and failings of the BLM to address impacts of the Ambler Road. The comment period is still open for the Ambler Industrial Access Road until mid-December, if you or any other tribal member would like to make a comment, let us know and we can make it happen. If you would like more information or to be included in some of our other mining issues, please let me know.






